

# **Quarterly Activities Report**

31 January 2021: Personalized Oncology life sciences company Invitrocue Limited (ASX: IVQ), ('Invitrocue', 'the Company' or 'the Group'), is pleased to provide this quarterly activities report to its appendix 4C reporting for the quarter ended 31 December 2020 (Q2 FY2021).

## **Operational cashflow**

The Group's revenue improved tremendously with the over \$\$572,000 collected in this quarter compared to \$\$391,000 collected in previous quarter, an increase of about 45%.

This is mainly due to the fulfilment of old orders and securing of new orders, a sign of the health care industry and the company's resilience in the midst of the COVID-19 pandemic.

The company continues to receive employment support from the Singapore government to the sum of S\$42,000 for this quarter.

## **New operations**

The JV with our Brazil partners as announced on 11 February 2020 is coming a fruition through the setup of lab and starting of the pilot operation in [city name of lab location], Brazil.

The Company is working closely with our Brazil colleagues and partners to prepare as much as possible so that the Brazil roll-out can be fast tracked once the COVID-19 situation eases.

### **Financial reports**

The Company is still working with its auditors on resolving the issues raised by auditors with regards to it 31 December 2019 half year report and 30 June 2020 annual report.

## Payments to related parties of the entity and their associates

A total of S\$128,000 has been paid to directors, of which S\$117,000 is for payment of directors' remuneration, while S\$11,000 is for payment of corporate services rendered by directors.
